ADDENDUM
DECLARATION OF PROTECTIVE COVENANTS
AND AGREEMENTS FOR
COUNTRYWOOD HIGHLANDS

THIS ADDENDUM to the Declaration of Protective Covenants and Agreements for Countrywood Highlands is made and entered into by Countrywood Highlands Developers Joint Venture, a general partnership, for the purpose of adding to the Declaration of Protective Covenants and Agreements for Countrywood Highlands as filed in the Office of the Judge of Probate of Jefferson County, Alabama and recorded in Real Volume 2514 at Page 385 (Article II, Building Requirements, #9, D Utilities, Wiring & Antennas) as follows:

ARTICLE II

BUILDING REQUIREMENTS

D) Developer agrees that the residents may join together, if so desired, and place street lights within the confines of Countrywood Highlands, provided it is approved by the City of Vestavia Hills.



Article III, Paragraph 2 shall be deleted and the following shall be substituted in lieu thereof:

2. ARCHITECTURAL CONTROL COMMITTEE: The Architectural Control Committee (the "Committee") shall be composed of three individual lot owners who, except for the initial committee, shall serve a three-year (3) term. The initial membership of the Architectural Control Committee shall be elected by a plurality of the lot owners. The proposed initial members and their initial term are as follows:

- Glenda Jones - 1 year term
- Alan Legg - 2 year term
- Charles Watkins - 3 year term

The lot owners shall have the right to elect the proposed members or such other resident or residents of Countrywood Highlands as the lot owners may elect. Any person elected or appointed to the Architectural Control Committee must be a resident of Countrywood Highlands and, after the initial committee, each person shall serve a three-year term. Successors to the Architectural Control Committee shall be appointed by the three members of the Committee at the last meeting of the Committee which shall occur during the month of April in each year. The year for service on the Architectural Control Committee shall be from May 1st to April 30th in each year. At least one member of each sex shall serve on the Architectural Control Committee at all times. In the event of the death, resignation, neglect or incapacity of any member of the Committee, the remaining members shall have the right to appoint another lot owner as successor to serve the remainder of the member's term. Each committee member shall serve, if able, until a successor is appointed. No committee member shall be allowed to succeed himself or herself. Any or all of the committee members may be removed from the Committee at any time by the vote of not less than Fifty-One (51%) Percent of the lot owners. In the event that any one of the Committee members is unable to meet, for any reason, the remaining members shall have all necessary authority and power to make decisions. The affirmative vote of a majority of the members of the Committee shall be required in order to issue any permit, authorization or approval pursuant to the directives and authorizations set forth herein. The Committee's approval or disapproval as required in these Covenants shall be in writing.

All other provisions of the Covenants referring to the Architectural Control Committee shall hereafter refer to the Committee as described and amended Paragraph 2 above.

IN WITNESS WHEREOF, the undersigned, representing in excess of Fifty-One (51%) Percent of the lot owners covered by the Covenants have executed this amendment by fixing their hands and seals as of the date recited herein.

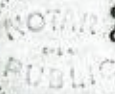
